Returning Officials Checklist

To be a "Member in Good Standing" and Eligible for Games:

1) Pay Dues by May 31st

Full Membership - \$45 (\$20 late fee if you pay after May 31st) Leave of Absence - \$15 (keeps you on the distribution list) Dual Membership - \$25 (out of state)

- 2) Pay annual MIAA dues of \$10 per sport and complete a background check if needed (this process becomes available after July 1st here)
 - Background checks are good for 3 years. The MIAA website will let you know if your background check has expired
 - Register Here (please do not use internet explorer)
 - Note: the MIAA account is not the same as your assignor's account. It is your responsibility to keep your background check and MIAA dues up to date
- 3) Sign in to BFHUA.com to check your Profile and update if needed
- 4) Complete the BFHUA Rules Test (available August 1st on the website)
- 5) Complete the online NFHS Concussion Course annually

In-Person Requirements:

- Attend a Mandatory Pre-Season Meeting (see table below)
- Attend a Re-rate Play Day if necessary (check your online profile to see if your rating has expired)
- Attend a service Play Day to get you ready for the season
- If you know anyone interested in becoming an official, you can send them this <u>link</u>. Registration closes August 10th.
